Guidelines:

- Applicants are responsible to seek vendor approvals with Joint Owner Independent Local Exchange carriers (ILEC's) and that One Touch Make Ready (OTMR) is consistent with any Collective Bargaining Agreements (CBA's) between the ILEC pole owner, Communications Workers of America (CWA) or another identity. If the pole owner has a CBA, then the contractor designated in the CBA is required to be used.
- If Applicants have a desire to use a communications contractor that is not on this list, please reach out to seek consideration of adding desired communications contractor to the approved list.
- Communications contractors must be licensed/qualified to work in communications space to be considered/added as an approved vendor.
- The One Touch Make Ready (OTMR) communications vendor list is intended for Simple Communications Make Ready. The activity is defined as such: "simple" make ready as "existing attachments in the communications space of a pole that can be transferred without any reasonable expectation of a service outage or facility damage and does not require splicing of any existing communication attachment or relocation of an existing wireless attachment."
- The OTMR Make Ready activities described are to be done exclusively in the communications space. The vendors listed should not be accessing the electric space on poles. To access electric space, they would need to be licensed and have proper qualifications/approvals from pole owners to do so.
- Applicants can utilize approved electrical make ready vendors from the NYSEG / RG&E New York Approved Line Construction list.
