



## NYSEG DEMAND RESPONSE PROGRAM APPLICATION

**Program Period: May 1, 2026 through September 30, 2026**

NYSEG administers peak shaving and contingency based demand response programs to manage energy usage from May to September. Demand Response programs are designed to maintain reliable service on the NYSEG electrical distribution system cost effectively.

Customers must submit an application as evidence of intent to provide load reduction in accordance with NYSEG's Tariff PSC No: 120 – Electricity, Leaf No. 117.46.8-117.46.17 as amended or superseded.

Enrollment in Commercial Demand Response Programs requires the installation an interval meter and a dedicated phone line to the meter. The customer must have a NYSEG approved interval meter and communications in place and operational prior to program participation.
